

# Sustainable Waste Management Services (EFM 5017 LU (Greater London))

In August 2014, LUPC awarded a new framework for Sustainable Waste Management Services, tailored predominantly for LUPC and SUPC Members with sites within Greater London. The framework has been extended until 31st July 2017 for Lots 1-3 (specific categories of waste), but lots 4 and 5, one-stop shop lots, have been terminated. As a result of one of the suppliers leaving the framework, there were only two suppliers on Lots 4 and 5 which didn't offer sufficient competition to Members. Although Lot 1 is only for General Waste, Dry Mixed Recyclables, food and green waste, bulky non-hazardous, metal and wood, and doesn't include hazardous, chemical and clinical waste, those Members wishing to incorporate this type of waste into their contract can do so providing it doesn't equate to more than 10% of their overall waste spend. There isn't any framework pricing for these waste elements on Lot 1, so although you can include it in your contract it will be outside the scope of the agreement.

#### **SCOPE**

The framework is made up of three lots covering general waste; dry mixed recyclables; food; green; bulk non-hazardous; wood; metal; hazardous; chemical; clinical; pharmaceutical; radioactive; and confidential waste.

### **AGREEMENT BENEFITS**

- An OJEU-compliant route through which Members can purchase a range of waste management services.
- A framework designed with Members specifically in mind, with input from a Project Team made up of procurement, operations and sustainability representatives from across the higher education and cultural sectors.
- Continued value for money for Members through the provision of a comprehensive, cost-effective waste management service with excellent service standards.
- Framework suppliers provide support to the Member Institutions through the provision of accurate waste data and assisting with increasing the amount
  of waste that can be recycled.

#### **USING THE FRAMEWORK**

There are between one and three suppliers in each of the framework lots and Members will undertake mini-competitions to choose the supplier(s) with whom they will enter into contract.

A detailed explanation of the mini-competition approach is provided in the Buyer's Guide, along with information on each of the suppliers; pricing; framework terms and conditions; specifications; and templates for undertaking mini-competitions.
