## SCOPE

This UK-wide agreement includes the supply of health and safety signage, way-finding consultancy, design services, manufacture, supply and the installation install of bespoke and customised signs and signage. Excluded from scope is the provision of digital signage (available through Audio Visual frameworks), online signage and mobile devices connectivity. If Lot1: A single supplier providing a catalogue of standard health and safety signs on a next day delivery basis. If Lot2: A one-stop shop organised regionally to provide either three or four suppliers offering an all-inclusive solution to complete in-scope requirements.
