### SCOPE

Include janitorial and cleaning supplies (including flooring/furniture care) and chemicals, dosing equipment, washroom dispensers, disposable paper products, soaps/hand cleansers and products, housekeeping equipment, and laundry products. Goods with sustainability credentials are encouraged within this. Personal Protective Equipment (PPE) and kitchen chemicals could also be considered in scope, although spend on these will likely be limited due to a range of other existing agreements more specifically for these.

### AGREEMENT BENEFITS

Discounts for internet-based orders, electronic invoice payments and sole supplier orders.

Cash-back member rebates for high annual spend.

Established core product list, with prices held for 24 months. Potential average BT1\* cash-based savings of 3.88% across suppliers

Discounted structure for a non-core product range (by manufacturer)

Potential to increase savings and value for money through further competition

Flexibility – you have the option of using e-procurement route or manual purchase orders dependent upon your institution's preferred approach

All awarded suppliers will arrange and provide free product training for all goods, if required.

You do not need to carry out a full EU tender but need to carry out a further competition with all of the suppliers on the relevant lot(s) that cover your requirements.
