### SCOPE

These "Goods" will be utilised in a range of areas including, residential accommodation, kitchens, teaching rooms, office spaces and gymnasiums. This list is not exhaustive.
- Lot 2 Street Furniture includes, but is not limited to the following scope; seating; benches; bollards; planters; bike shelters; bike parking; smoking shelters. This list is not exhaustive.
