**AGREEMENT BENEFITS**

- All suppliers have passed through a thorough examination at PQQ and ITT stage and have been rigorously evaluated by a Tender Working Party consisting of both Procurement and Estates Personnel
- The framework, as proposed, provides significant flexibility enabling institutions to access a range of suppliers
- The framework provides access to all of the key players in the industry
- The detailed requirements specification within the ITT to which suppliers have confirmed compliance where required will allow institutions to move to direct award or further-competition in a short time-frame
- The framework will provide for payment term discounts of between 0.5% and 1% for payment in 14 days and aggregate spend rebates per lot area of between 1% and 5% based on a sliding scale of spend and payable direct to institutions within the lot area on an annual basis, thus enhancing the drive to increase collaborative spend within HEI's
