This Agreement is not broken down into Lots. All nine suppliers are able to provide a full range of core products and a selection of optional products.

Call-off patterns will usually be agreed locally with advice from your procurement department and may include:

- Choosing single or multiple suppliers
- Undertaking a mini-competition for specific requirements
- Selecting the most economically advantageous offer
