		Jisc statement 14/7/17: Due to the recent acquisition of Brocade by Extreme Networks and re-branding of Brocade products to Ruckus, the Brocade brand will essentially disappear. The manufacturer has made assurances that existing product lines will continue to be supported and developed and the same part codes will continue to be used.
