#### **SCOPE**

This agreement covers the supply of general laboratory chemicals including fine chemicals, solvents and general chemicals, but does not include chemicals such as antibodies, oligos and DNA used in life sciences. This agreement replaces the chemicals lots of the recently expired IRLA (2010-14), and the Fine Chemicals Agreement tendered by APUC Scotland which expired in May 2015.

The agreement has been awarded to the following five suppliers: Avocado (trading as Alfa Aesar), Fisher Scientific, Scientific Laboratory Supplies, Sigma Aldrich and VWR.

#### **AGREEMENT BENEFITS**

- Provides compliance under EU Procurement Directives.
- No lots means all 5 suppliers are able to compete for all the business on product, price and service.
- Offers very competitive pricing.
- Provides supplier next day delivery, e-catalogues, dedicated pricing on supplier websites, e-invoicing and free waste collection (for packaging and chemicals).
- Offers core list items and non-core list items within the general scope of the framework at heavily discounted prices.

Fisher, Sigma Aldrich, Scientific Laboratory Supplies and VWR can collect empty bottles free of charge and can offer a removal service for redundant or waste chemicals and solvents – this is a separate service and fee will have to be agreed with the supplier.

Alfa Aesar will provide on request, reputable information on third parties that can undertake this service.
