The agreement is split into two lots.

Lot 1 Recycling Bins

A wide variety of both internal and external bins in an assortment of sizes and materials suitable for a range of purposes.

The agreement includes the provision of signage and educational materials to support waste recycling campaigns.

‘Smart’ waste solutions are also included within the scope.

Lot 2 Street Furniture

A wide variety of products for external use including seating, road safety products, shelters and small structures.
